- ^a Charities will normally not know which, if any, of their volunteers incurred out-of-pocket expenses of \$250 or more with respect to a particular charitable activity or event. As a result, they should provide an acknowledgment such as the one shown here to each volunteer who could have reasonably incurred at least \$250 of unreimbursed expenses.
- If the charity did provide any goods or services in connection with the volunteer's efforts, a description and good faith estimate of the value of those benefits should be included in the letter. However, if the only benefits provided were intangible religious benefits, a statement to that effect should be made (rather than providing a description and valuation of the benefits). Intangible religious benefits are those items provided by a church that are generally not sold in a commercial transaction outside of a donative context (e.g., admittance to a worship service).

Sample Letter to Charity Requesting Written Acknowledgment

Dear Charity:

As you probably know, my charitable donations of \$250 or more and all of my cash donations (where I lack a bank record) are not deductible for federal income tax purposes unless I receive a written acknowledgment from the charity. The acknowledgment must include the amount of cash and a description (but not the value) of any other donated property, a statement indicating whether the charity provided goods or services in return for my donation, and if I was provided with goods or services, a description and good faith estimate of the value of such items (or if the only items provided were intangible religious benefits, a statement to that effect).

In gathering my tax information for last year, I was reminded that I made one or more donations of at least \$250 to your organization during [Year]. However, I did not receive an acknowledgment of the donation(s) (or the acknowledgment I received did not include the required information). As soon as possible, please provide me with an acknowledgment of my [Year] donation(s) that includes the information listed above. Alternatively, you may complete the bottom portion of this letter and return a copy of it in lieu of providing a separate acknowledgment.
